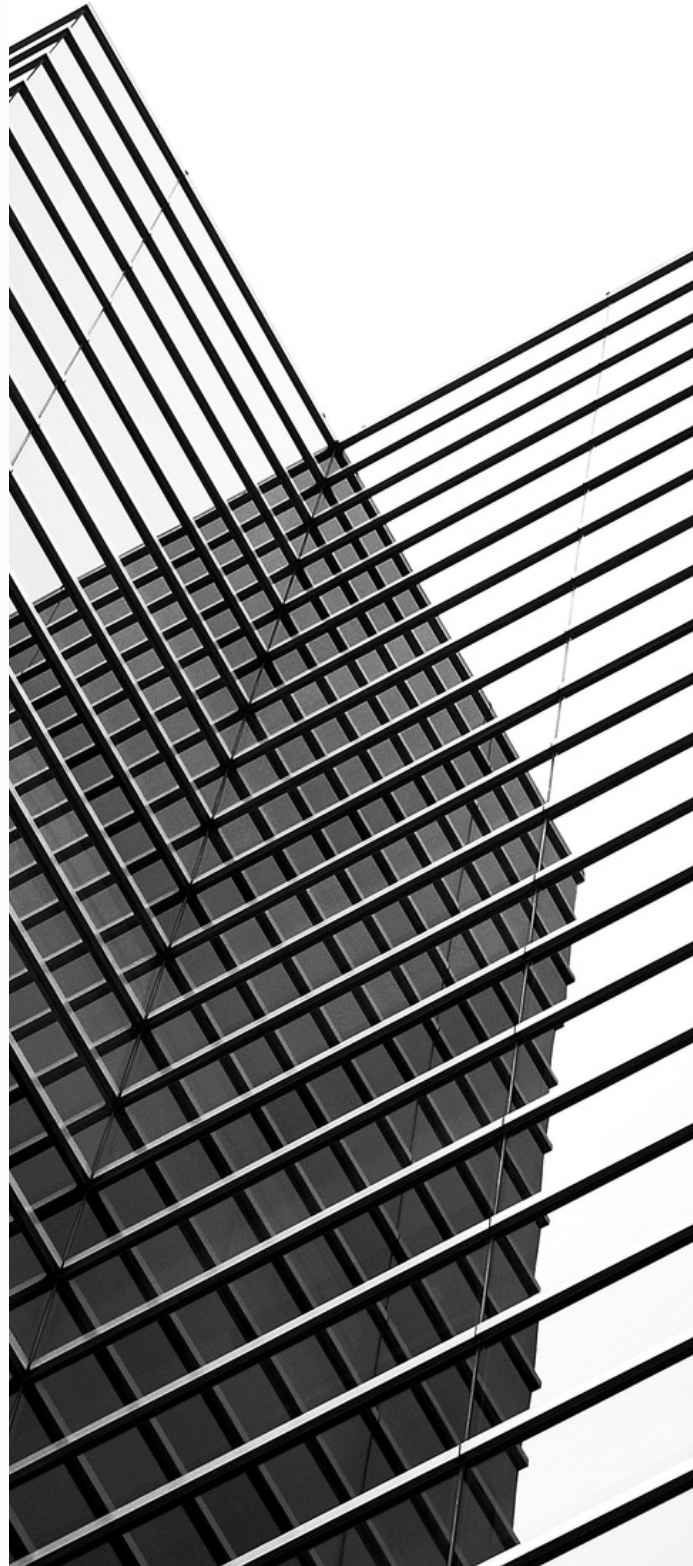
About Our Firm

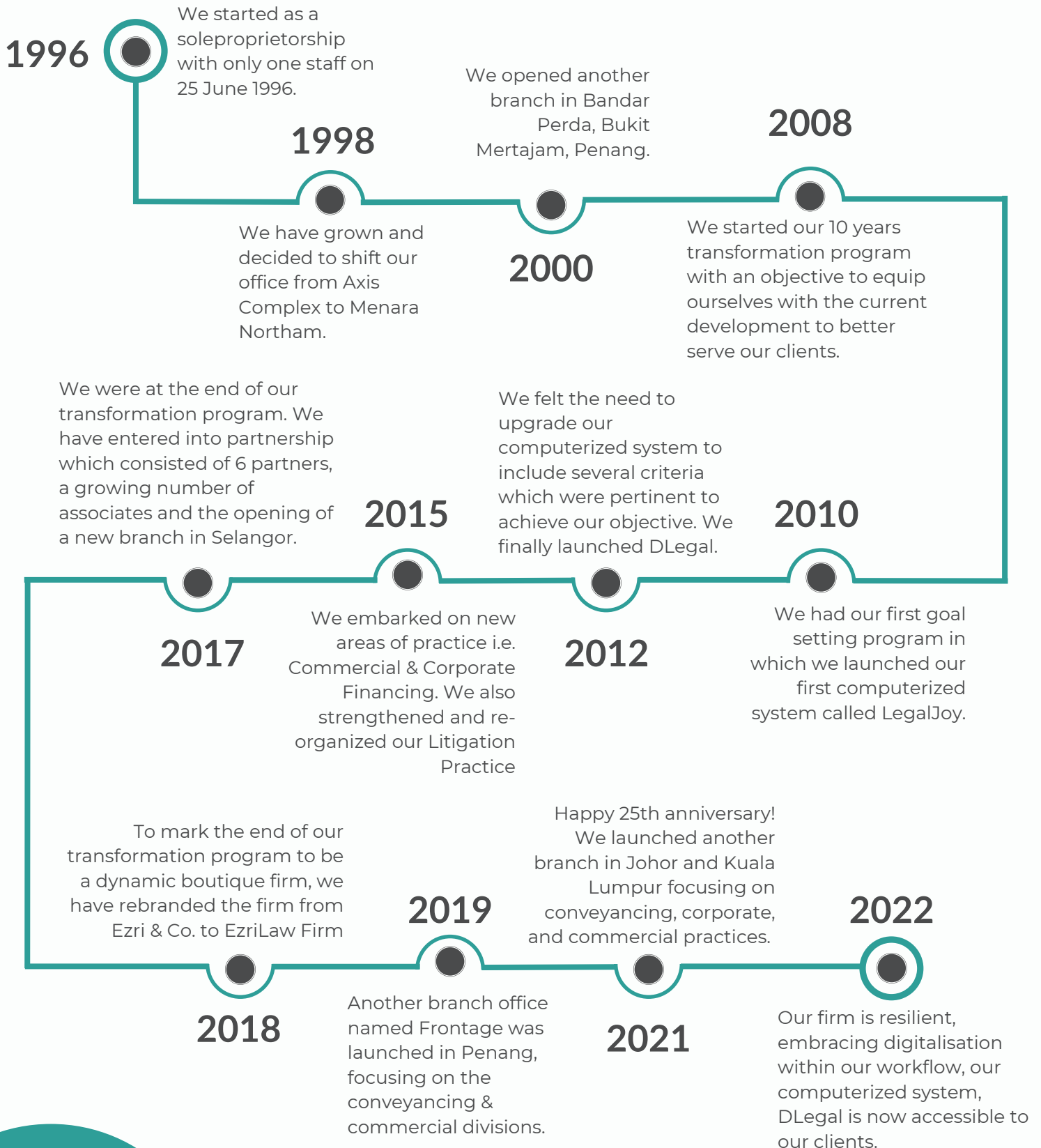
Our vision is to serve the needs of all clients with utmost competency and respect through honest and responsive communications, while employing innovative approaches to address legal concerns, problems and opportunities.

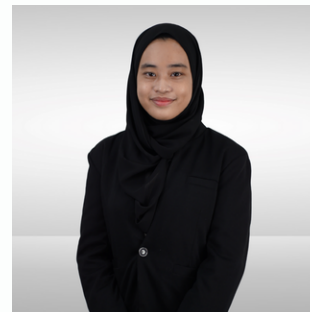

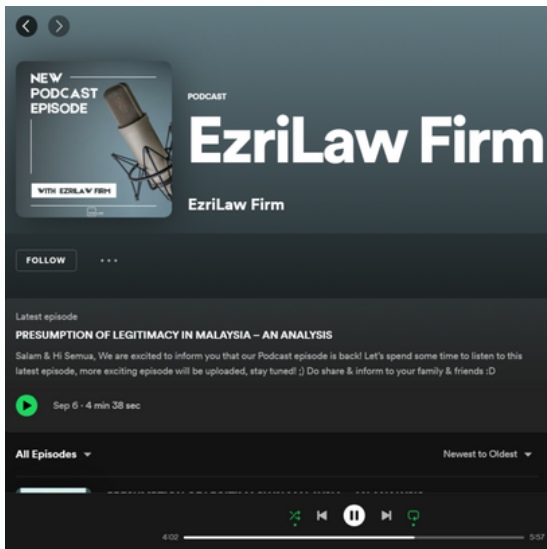
